Flea Market Regulations

Terms of Agreement: This agreement is for flea market vendors at Christian Community Church of Mars, known as CCCM. All vendors are independent operators and not affiliated with CCCM. The vendors agree that CCCM may revoke this agreement at any time and for any reason. Non-compliance of the rules as outlined in this agreement or in further notices will result in removal of vendor with no refund due vendor. CCCM reserves the right to decline access to vendors who have not cooperated with the guidelines of this agreement in the past. This agreement is valid for this calendar day only.

Booth Space and Size: All booth spaces will be 10' wide by 18' deep. CCCM will assign a booth space to each applicant. Once your space is assigned, you can not relocate to another space. Booth spaces are assigned at the discretion of CCCM and is non transferable. A vendor forfeits his or her space upon termination of this agreement by either party, and may not transfer it to a third party.

Garbage/debris: Vendors shall be responsible for removal of their own garbage and shall leave the space as clean as when they arrived. No provision will be made by CCCM for removal of garbage or debris.

Rental fees: Vendors will be charged \$12 per space or \$20 for 2 spaces for the day.

Equipment: This agreement is for the space rental only. CCCM does not supply any equipment which may be necessary for the operation of vendor's booth. Electrical service is not available. Restroom facilities are available.

Determination: All matters regarding compliance with or violation of the rules and regulations will be determined by the CCCM representative and all decisions are final.

Prohibited Items: Any item prohibited under PA State Law - GUNS, SWORDS, BLOWGUNS, PORNOGRAPHIC MATERIAL OF ANY KIND, DRUGS OR DRUG PARAPHERNALIA, ALCOHOL, MOVIES, GAMES AND CD'S rated PG-13, E-10 or CD's with explicit language. CCCM retains the right to determine the appropriateness of materials for sale on its property. Materials deemed inappropriate must be removed from sale and public display.

Rules for Flea Market

Flea Market days will be the 2nd and 4th Saturdays of each month, starting in May and continuing through September. Set up times will be from 7am - 8am. The flea market will be open from 8am - 1pm.

Rules:

The rules that follow must be adhered to or you will immediately forfeit any opportunity to participate in the rest of years events. Please read the following contract carefully, then sign and return with your payment.

1. This is a family event, no alcohol, drugs, pornographic materials, etc are permitted on premises.
(Please see prohibited items on page 1)
2. The speed limit is 5mph on the church grounds.
3. You are responsible for the supervision of your children. CCCM is not liable for any injury.
4. No food or drink can be sold without the prior consent of the flea market co-coordinator.
5. This is a rain or shine event. No refunds will be issued.
6. No pets are allowed.
7. You must supply your own tent, tables and chairs. No electricity will be available.
8. You are responsible for the set up and clean up of your own area. You must remove all trash and take it with you. Vendors are responsible for any damages to the premises caused by set up or tear down of equipment.
